Requirements for payment of priority stipend

- 1. Households whose Basic Resident Register is registered in this city as of the record date (December 13, 2024), and all the household members are exempt from residence tax for FY 2024.
- 2. No member of the household is dependent on "other relatives, etc. who are subject to resident tax in FY2024".
- 3. You are not receiving similar benefits in any other city, town, or municipality.

Requirements for additional child allowance

Households receiving the Priority Stipend in Response to Rising Prices (30,000 yen) that have a child or children living in the same household as of the record date (December 13. 2024).

- *Applicable for children under 18 years of age (born on or after April 2, 2006).
- *Not applicable for children residing overseas who are not registered as residents of Anjo City.
