## Information on "Priority Stipend for FY2024 in Response to Rising Prices (Additional Child Allowance)"

### 1 Introduction

Under "Comprehensive economic measures for the security and safety of the people and sustainable growth," low-income households that are suffering most severely from the effects of high prices of food, energy, and other consumer expenditures will receive 30,000 yen per household. In addition, among such eligible households, those with children under 18 years old (born on or after April 2, 2006) will receive 20,000 yen per child.

Please fill in the required items on the enclosed "Confirmation Undertaking of Requirements for Priority Stipend for FY2024 in Response to Rising Prices (Additional Child Allowance)" and send back this confirmation letter in the enclosed return envelope.

You can also apply using the QR code provided on the confirmation undertaking and notice.

Please note that the funds will be transferred to your account approximately one month from the date of receipt of the confirmation undertaking.

\* As a rule we do not deal with applications at the City Hall counter, so please submit by post or through electronic application.

### 2 Eligible applicants (households that meet all of the following conditions)

### **Priority stipend**

- O Households registered as residents in Anjo City as of December 13, 2024
- O Households consisting solely of residents who are exempt from residence tax for the FY2024 (both per income and per capita basis)
- O No member of the household is dependent on "other relatives, etc. who are subject to resident tax in FY2024"
- O Households not receiving a similar benefit (30,000 yen) from municipalities other than Anjo City
- \* A household is not eligible if it includes "a foreign national who is exempted from resident tax based on tax treaties"

#### Additional child allowance

- O Households with children aged 18 or younger who belong to the household of the recipient (head of the household) of the above benefits (children born on or after April 2, 2006)
- \*Newborns born on or after December 14, 2024 are also eligible (a separate application form for newborns must be submitted)
- \*Children who live in a separate household but share the same livelihood as the head of the household are eligible (children living overseas are not eligible)

### 3 Payment amount

Priority stipend

Payment amount 30,000 yen per household Recipient

Additional child allowance

Payment amount 20,000 yen per child

\*The beneficiary account will be the same as the one receiving the benefits (30,000 yen) and the additional child allowance.

## 4 Application procedure

**Electronic** application \*Please apply by May 31, 2025 (before date change).

\*If you submit an electronic application, you do not need to return this confirmation undertaking.

\*Please refer to the home page of electronic application for the procedure.



### **Application with** confirmation undertaking

\*Please return the confirmation undertaking by May 31, 2025 (as indicated by the postmark).



\*After review, we will transfer the benefits to your account.

\*For both electronic application and confirmation undertaking, it takes about one month from the date of receipt by Anjo City to transfer the funds to your account.

\*There is a possibility that the bank transfer will be delayed during the Golden Week and around that time.

\*Those who return the confirmation undertaking should make a note of the inquiry number or keep a copy of the confirmation undertaking.

# 5 Application deadline \*Please note that electronic applications may not be accepted if the date changes during the application process (June 1, 2025), so please apply well in advance.

#### By May 31, 2025 (as indicated by the postmark)

- If you do not return the confirmation undertaking or do not submit electronic application by the deadline, it will be deemed that you have
- If the benefit transfer cannot be made for any reason, the city will contact the beneficiary, but if the confirmation is not received by the end of May, the beneficiary will be deemed to have declined the benefit.

## 6 Change of beneficiary account

If you "would like to receive the benefits into another account," please fill out the necessary information and attach the following documents to the center-right side of the confirmation undertaking.

Nousehold owner's identity verification document (copy)

Driver's license, individual number card (front), basic resident register card, passport, residence card, special permanent resident certificate, health insurance card, pension book, welfare recipient certificate, etc.

\*Please copy the part where your name and current address are written.

Confirmation document of designated account (copy) of the head of the household

Passbook of the designated account or cash card

\*Please copy the part where the financial institution name, branch name, account type, account number, and account name (on the back of the passbook cover) are listed

### For those who are unable to open an account

In principle, this benefit will be paid by "bank transfer." However, if there is an unavoidable reason such as inability to open an account with a financial institution, the city can specify the date and time for cash payment.

If you wish to receive the payment in cash, please contact the Benefit Call Center below.

\*Payment by cash will take longer than by bank transfer.

### 8 When a person other than the head of household (alternate beneficiary) receives the benefit

This payment, as a rule, is deemed to have been paid to the "head of household." However, the payment may be made to an alternate beneficiary other than the head of the household only if there is a compelling reason for doing so, such as difficulty in returning the confirmation undertaking by the head of the household.

Procedure by alternate beneficiary

Fill in the required items in the alternate beneficiary column at the bottom right of the confirmation undertaking and the designated account column at the top right, and please paste the following documents at the center of the right side.

- Identity verification documents (copy) of the head of household and the alternate beneficiary
- Verification documents (copy) of the designated account of the alternate beneficiary
- Procedure for representation under the adult guardianship system

Please attach the following documents. There is no need to fill in the alternate beneficiary field.

- Adult quardian
- Guardian/Assistant
- "Certificate of registration (copy) based on the adult guardianship registration system" "Certificate of registration (copy) based on the adult guardianship registration system"
- "List of alternate beneficiary's rights (copy) that confirms that the proxy right for receiving public benefits

## Reference Those who are exempt from resident tax

Those who are exempt from resident tax in Anjo City are as follows.

Those who have no dependents and whose total income is 420,000 yen or less

Example: Salary income alone is 970,000 yen or less, or pension income alone is 1.52 million yen or less (65 years or older)

Those who have dependents and whose total income is less than or equal to the amount as per the following formula 320,000 yen x (1 + number of dependents) + 289,000 yen

Example: If there is only one dependent relative Salary income alone is 1,479,000 yen or less

Pension income alone is 2,029,000 yen or less (65 years and older)

Salary income alone is less than 1.9 million yen (1,899,999 yen or less) If there are two dependents

Pension income alone is 2,349,000 yen or less (65 years and older)

- Persons with disabilities, minors, widows or single parents with a total income of 1.35 million yen or less
- Welfare recipients (Livelihood Assistance)
