Submitting the Declaration of Beneficiary of the Child Allowance and Special Benefit

"Jido Teate, Tokurei Kyufu Genkyo Todoke(Reiwa 3-nendo)"

If you receive the Child Allowance, you must submit the annual declaration form of your current status in June every year. Please submit the enclosed declaration form 「児童手当・特例給付現況届 (令和 3 年度)」 "Jido Teate, Tokurei Kyufu Genkyo Todoke(Reiwa 3-nendo)" by the due date as shown below.

### 1. Required Document

- (1) The Declaration Form of 「児童手当・特例給付現況届(令和3年度)」"Jido Teate, Tokurei Kyufu Genkyo Todoke(Reiwa 3-nendo)"
- (2) A document of 「児童手当・特例給付 国外居住申立書」"Jido Teate Tokurei Kyufu Kokugai Kyojyu Moshitatesho"

For those who have a residents card of Japan as of 1st June 2021, and entered Japan after 1st January 2021.

- \*We enclosed the document for a relevant person, Please contact Kosodate Shien-ka, if it cannot be found.
- XBoth recipient and spouse need to submit it.
- \*No need for a person living abroad as of 1st June, 2021.
- (3) A document of 「児童手当・特例給付 別居監護申立書」"Jido Teate・Tokurei Kyufu Bekkyo Kango Moushitatesho" (Separated Guardianship Statement) Recipients who have the custody but being separated from a child.

### 2. How to submit

- (1) Mail (by using the enclosed stamp-free envelope).\*Submitting by mail is recommended.
- (2) Bring directly to Kosodate Shien Ka, Jidoukyufu Gakari (Department of Child Care Support) at Anjo City Hall (No.3, 1F, Main Bldg.)
- (3) Bring directly to Anforet (Anjo City Library) or any of branch office, Meisho, Sakurai or Hokubu. (only accept the completed form)
- (4) Electronic application system called 「あいち電子申請・届出システム」is available. (Need recipient's the Social Security and Tax Number Card and IC Card Reader)
  - \*This system is Japanese language only.

### 4. Others

- (1) You don't have to attach a copy of your insurance card to the from. (We will check your pension information using your Social Security and Tax Number from June 2020).
  - \*However, it is necessary to attach a copy of the insurance card in the following cases.
  - As a result of inquiring information from the Japan Pension Service, if the included pension information cannot be confirmed (We will request a copy of your insurance card at a later date).
  - If you does not agree to using your Social Security and Tax Number.
- (2) If you do not submit the required documents, you will no longer receive any more allowance beyond June 2021 (which will be transferred to your bank account after October 2021).

#### 5. F.A.Q

- Q. Can we change a bank account for transfer?
- A. Only recipient's bank account is acceptable. Not possible to change to your spouse's account or child's account. For the change, please apply by;
  - 1) Print 「児童手当変更届」(Jido Teate Henko Todoke) out from the website, fill out the necessary points and mail it with a copy of a new bank book to Anjo City Hall.
  - 2) Bringing a new bank account book to Anjo City Hall directly
- Q. What is the 「特例給付」"Tokuei Kyufu" ?
- A. It is a temporary special benefit for whose income is higher than income cap. After submitting the form, We will decide the determination income of 2021 (which is calculated based on 2020) of yours, and inform you as needed.
