

## Anjo City Elementary and Junior High School School Lunch Fee FREE Project

(If enrolled in a school that is not a public school in Anjo City)

**In order to reduce the economic burden on families with children, we will provide subsidies for school meal costs for students enrolled in elementary and junior high schools based on applications. Those who meet the eligibility requirements and wish to receive the subsidy should review the requirements below and submit their applications. (Even if you meet the criteria, you cannot receive the subsidy without an application.)**

### ◆ Eligibility Requirements (Must meet both ① and ②)

- ① The resident registration of the students<sup>(※1)</sup> and their parents or guardians is in Anjo City. <sup>(※1)</sup> Students whose address is outside the city due to programs such as rural study abroad are eligible for the subsidy.
- ② At the time of application, the student is enrolled in a non-public elementary or junior high school in Anjo City<sup>(※2)</sup>. <sup>(※2)</sup> This includes non-public elementary and junior high schools, schools for compulsory education, the lower secondary level of secondary education schools, and the elementary and junior high divisions of special support schools.)

### ◆ Subsidy Amount

Actual number of meals served (number of scheduled school meal days in Anjo City public schools) × meal unit price (elementary school: 330 yen, junior high school: 380 yen) \*Note that the meal unit price may change. However, the maximum amount will be the amount provided in Anjo City public elementary and junior high schools, and the amount will be reduced if any of the following conditions apply during the subsidy eligibility period.

- At the school where you are enrolled, school meals are provided free of charge in full due to policies from the national government, local authorities, and others.
- Regarding the costs related to school meals, additional assistance is being received from the national government, local authorities, and others.

### ◆ Application Method (Apply using method ① or ②)

- ① Please submit the documents below to the General Affairs Section, School Meal Division.
  - Application Form for Subsidy for School Meal Costs for Students in Anjo City Elementary and Junior High Schools (Form No. 1)
- ② Please enter the necessary information in the Aichi Electronic Application and Notification System for the 'Application for Subsidy for School Meal Costs for Students in Anjo City Elementary and Junior High Schools' and submit your application. (Information can be entered from April 1, 2026 (Wednesday) onwards).

- ◆ **Application Period**...Applications will be accepted at any time. (Subsidies will be applicable starting from the month following the application month.)
- ◆ **Grant Decision**...Beneficiaries of the subsidy will be notified separately, but the eligible period for the subsidy will be the decision period following the submission of the application. The amount of the subsidy will be finalized after reviewing the performance report.
- ◆ **Performance Report**...Please submit the performance report by the end of the fiscal year.
- ◆ **Payment Timing**...Payments will be made by May of the following year based on the performance report submitted by the end of the fiscal year.
- ◆ **Important Notice**...If there are any changes to the application details after submission, please notify us within one month of the change. Please be aware that those eligible for the subsidy this fiscal year will need to reapply if they still meet the conditions in the following year. Applications must be submitted by the last day of the month preceding the start month of the eligible period (if the start month is April, the deadline will be the day before the start of school meals in public schools in Anjo City).

**In order to receive the subsidy for the year, applications must be submitted by April 13, 2026 (Monday). (For mailed applications, the postmark will be considered valid.)**
