Information on School Aid System (overview)

Anjo City Board of Education

1 Who is qualified to receive school aid (reasons for approval)

Those who live in Anjo City and are the guardians of children or prospective students of elementary or junior high schools in the city, town or village, and who have any of the following reasons, are qualified for the School Aid approval.

1. Receiving public assistance.
2. The public assistance has been suspended or abolished.
3. The citizen tax was exempted.
4. The citizen tax was reduced.
5. The individual business tax was reduced.
6. The property tax is reduced.
7. The National Health Insurance tax was reduced
8. National health insurance premiums were reduced or deferred.
9. National pension contributions have been reduced.
10. Received child support allowance.
11. Received a loan from the welfare fund (livelihood welfare fund).
12. The person is in need to the same level as a person in need of public assistance. (※1)

※1 The decision will be based on the applicant's household income.

2 Details and Amount of School Aid Expense

The amount will be decided and paid each semester for the expenses listed in the table below.

※2 Only approved applicants who apply by April 30 will be paid. You may also apply before enrollment. In that case, the payment will be made in March before enrollment.

※3 Those who have been continuously approved since elementary school ・ ・ ・ will be provided in the third semester of the sixth grade.

For those who will newly apply ・ ・ ・ Only those approved who apply by April 30 will receive the payment. You can also apply before moving on to junior high school. In that case, the payment will be made in the third semester of the 6th grade of elementary school.

3 How to apply

(1) Application method

Please apply to the school where your child is enrolled. Forms are at the school.

[For preschool children, the application form and other documents are enclosed in the information notice of the entrance orientation (you will receive it around January before the enrollment)].

(2) Documents for submission

[Taxation (tax exemption) certificate for those who have income (only for applicable people※4)]

※4 In the examination for approval, we will verify your income. However, if we are unable to verify your income because you have moved into the area or have not reported your income, we will ask you to submit your taxation certificate [課税証明書].

(3) When to apply and where to submit documents

4 Payment timing and method

The number of times of School lunch and expenses are calculated for each semester and paid after the end of the semester (generally in August, January, and April). For school supplies for newly enrolled students, it is possible to receive it in March before they enter school (or advance to the next grade) (there are requirements for the time of application).

However, if there are any unpaid payments in collections at school, the payment method may be changed to a transfer to the account of the principal of each school, and the remaining amount may be provided in cash after the expenses are settled at each school.

5 Wi-Fi router rental

To improve the home Internet environment for students and promote the use of tablet devices, we will rent Wi-Fi routers for free (※5) to approved applicants who want it. (※5) The capacity is 10 GB/month. (※5) After approval, we will investigate your request for rental.

※5 However, if you have an unlimited Wi-Fi router in your home, you are not qualified for rental.

6 Procedures after approval

Every year around September, the Board of Education will send a “School Aid Payment Current Report and Household Form” to the person receiving the aid to confirm the household's situation. Those who want to continue receiving the aid are required to fill out the form and submit it to the school they are enrolled in by the specified deadline. If you do not submit the form, your school aid will be discontinued. Even if you submit the form, you may not be able to continue receiving school aid based on the results of the screening process.

7 Withdrawal or suspension of school aid

If you no longer need school aid due to a change in your family situation, such as moving to a new address or getting married, after applying or being approved, please submit a letter of withdrawal to the school. In addition, school aid may be stopped if the reason for the approval disappears due to a change in family or income status.
